We'd like to share information on upcoming Public Information Sessions and Statement Hearings set by the New York Public Service Commission (PSC) for the Empire Wind 2 project. These sessions offer the opportunity for members of the community to speak with the Public Service Commission and Equinor about the Empire Wind 2 project.

These sessions are set and run by the New York State Public Service Commission.

During the Public Information Sessions on <u>March 2nd at 1pm & 5pm</u>, the Department of Public Service (DPS) will provide an overview of the PSC's certification process, Equinor will provide a project summary, and the public will have an opportunity to ask questions.

The Public Statement Sessions on March 9th at 1pm & 5pm will be only for the public to provide comments on the project. Please note that for this session, any person wishing to provide a public statement on the record must pre-register to do so by 4pm on Tuesday, March 7, 2023.
