Notice to Proceed with Part 2A Construction

Dear Ms. Senlet:

The Application submitted by the Empire Offshore Wind LLC (Certificate Holder or Empire Wind) to construct two 230-kilvolt (kV) high voltage alternating current (HVAC) submarine export cables within an approximately 15.1 nautical mile-long submarine export cable corridor, extending from the boundary of New York State waters to the cable landfall and two, 0.2 mile-long 230-kV HVAC onshore export cables buried underground from the cable landfall to a new onshore substation at the South Brooklyn Marine Terminal (SBMT), along with two 345-kV HVAC underground cable circuits connecting the new onshore substation at the SBMT to the interconnection at Con Edison's Gowanus 345-kV Substation in Brooklyn, New York, was approved by the New York State Public Service Commission (Commission) on December 18, 2023, pursuant to Article VII of the Public Service Law. On June 21, 2024, the Commission issued an order approving Empire Wind's Environmental Management and Construction Plan for Part 2A of the Project (Part 2A EM&CP). Ordering Condition 3 of the Part 1B EM&CP Order states:

2. The Certificate Holder shall not commence construction until it has received a "Notice to Proceed with Part 2A Construction" letter sent by the Chief of Environmental Certification and Compliance of the Office of Energy System Planning and Performance, or by a designee.

Department of Public Service (DPS) Staff have determined that the information provided by Empire Wind, in conjunction with the Commission's approval of the Part 2A EM&CP and required pre-construction notifications, meet the requirements to satisfy a Notice to Proceed with Part 2A Construction.

Empire Wind is hereby authorized to begin Part 2A construction activities within the Project area boundary where all applicable permits/agreements have been received and provided to DPS Staff.
