## **NOTICE OF START OF CONSTRUCTION**

PSC Case 21-T-0366 — Application of Empire Offshore Wind LLC for a Certificate of Environmental Compatibility and Public Need for the Construction of Approximately 17.5 Miles of Transmission Lines from the Boundary of New York State Territorial Waters to a Point of Interconnection in Brooklyn, Kings County.

On or about October 16, 2024, the New York State Public Service Commission is expected to approve the Part 3 Environmental Management and Construction Plan (EM&CP) for parts of the New York portion of the transmission facilities (the Project) required to interconnect Empire Offshore Wind's (Empire) proposed 816 megawatt (MW) Empire Wind 1 Offshore Wind project (OSW Facility) to the New York State Transmission System.

The Project will interconnect to the New York State Transmission System operated by the New York Independent System Operator, Inc. (NYISO) at the Gowanus 345 kV Substation (the point of interconnection, or POI). The Gowanus 345 kV Substation is owned by the Consolidated Edison Company of New York, Inc. (Con Edison). The Project's onshore facilities, including the onshore cable route, onshore substation, and the POI, are located entirely within Brooklyn, Kings County, New York.

The approved Part 3 EM&CP addresses construction and operation of the Project's aboveground facilities at the onshore substation within the South Brooklyn Marine Terminal (SBMT), onshore cable pulling along the interconnection route within 2<sup>nd</sup> Avenue that terminates at the POI at Gowanus Substation, control buildings, equipment buildings, electrical works, as well as operations and management (O&M) and decommissioning of the Project's EM&CP Part 3 onshore facilities.

## The construction of this portion of the Project is anticipated to start on or about November 4, 2024.
